


## TTP1-M - Turf-Tec Tubular Turf Plugger Instructions

The Turf-Tec Tubular Turf Plugger removes grass plugs 2-3/8 inches wide by 2-1/2 inches deep. The hollow handle fills up with 20 plugs, and the plugs are





Simply plug the bad areas with the Turf-Tec Tubular Turf Plugger and the hollow handle fills up with plugs. Dump the damaged plugs



out of the hollow handle and replace with healthy grass. Since grass plugs fit perfectly back into holes, there is no evidence of repair, except for green grass! Studies indicate plug size is ideal for quickest turfgrass establishment. Cutter blade is case-hardened steel and is also replaceable.

## Instructions

- 1. Hold Tubular Turf Plugger by both handles over area of good turf and press down into soil until flange hits the soil surface. Be sure not to hit rocks.
- 2. Turn Tubular Turf Plugger 1/2 turn towards the left and 1/2 turn towards the right to shear the roots.
- 3. Raise Tubular Turf Plugger from soil and repeat process until the handle is filled with plugs.
- 4. Turn unit upside down allow plugs to slide out handle.
- 5. Repeat the same process for area to be repaired and discard plugs from damaged area. (You can also save the soil for step # 8).
- 6. Plugs from the good area are easily put into empty holes made from the Tubular Turf Plugger in the area to be repaired.
- 7. A small amount of organic fertilizer like Milorganite can be placed in empty hole before the green plug is planted to allow quicker establishment. (Use only organic fertilizer to insure roots are not burned.)
- 8. Areas with plugs removed can be backfilled with a combination of soil and fertilizer to allow re-growth from surrounding grasses.
- 9. When cutter blade is worn, it can be replaced with a new cutter blade.
